The current giving model involves distributing household grants of \$1,000 over a nine month period. GiveDirectly aims to help households most in need by targeting those that are in acute poverty. Recipient households are currently identified based on housing construction material, which is highly correlated with poverty. Houses which are made from mud-and-thatch in areas in which the Organization operates are eligible for the program. The Organization aims to deliver at least 90 cents directly to recipients of every \$1.00 received for the program. The Organization anticipates expanding to additional countries in the developing world.
